



YOUR WORKOUT ON YOUR TIME

24-Hour Access - Oil City YMCA

- You must be 19 or older to apply for 24/7 access.
- At no point, regardless of the situation or for any reason, can any member under age 19 remain in the YMCA after the building has been closed by staff.
- You must be a member of the Scenic Rivers YMCA.
-not available for Nationwide Members or guests.
- You must sign a waiver and submit a FREE PA State Police background check.
- You must pay a \$25 key card activation fee.*
- We recommend that you exercise with another 24/7 member when using our facility outside of staffed hours (Ask about our BFF program!)
- A telephone and AED are available in the Front Desk Area
-In case of emergency, please call 911.

- Park in the side parking lot and enter and exit the building at the 24/7 access entrance.
- When entering and exiting, please ensure the door closes behind you.
- Use caution in inclement weather as snow and ice removal will not be enforced until staffed hours, possibly later.
- Do not hold the door for anyone. Everyone must use their own key card for access so we can track who is in the building at all times. Key cards may not be shared with anyone. Doing so is a violation of our policy and will result in you permanently losing 24-hour access and a possible termination of your membership.
- The Wellness Center, Gym, Free Weight Room, Track, and Restrooms are the only areas available, The pool, Locker rooms and Multi-Purpose Rooms are not available.

Applications are available at the membership desk and on our website. Starting Nov 28th!

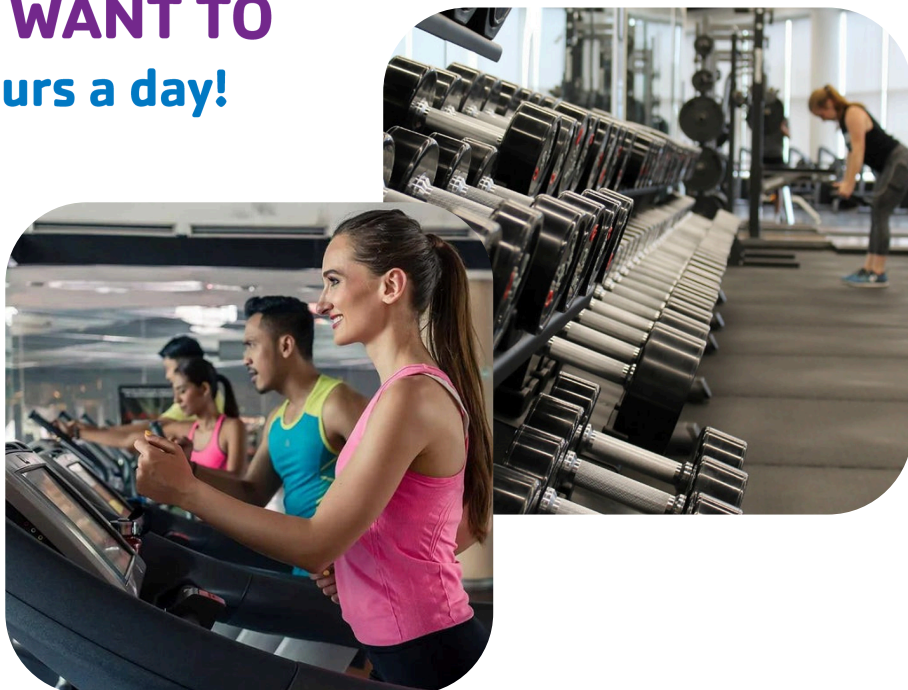

24/7 ACCESS | FAQ

Q: I am already a member of the Scenic Rivers YMCA, so will I be able to use the 24/7 Access Door after hours?

A: No, everyone must submit an application and wait for approval, then sign a waiver and pay a \$25 activation fee* to be able to use the 24/7 Access Door after hours.

Q: Does the 24/7 Access Door only work Monday-Friday?

A: No, the 24/7 Access Door works every day after the Y's regularly scheduled business hours.

Q: What if I come in to workout a half-hour before the end of regular business hours?

A: We will not make you leave when the building closes, but you no longer will have access to any area of the Y except the wellness center, gym, and restrooms. If you left your clothes or keys in a locker in the locker room, you will NOT be able to retrieve those items until our regularly scheduled business hours.

Q: After I pay the activation fee, can I bring a friend or family member with me after hours?

A: No, everyone must use their own key card for access so we can track who is in the building at all times. Key cards may not be shared with anyone. Doing so is a violation of our policy and will result in you permanently losing 24-hour access and a possible termination of your membership.

Q: Who qualifies for 24/7 wellness center access?

A: Members in good standing for at least 30 days ages 19 and up ship dues must be paid on time to keep your 24/7 access active!

Q: What if I have an emergency while using the facility after hours?

A: There will be a clearly labeled telephone, AED, and first aid kit in the wellness center. You should call 911 for an emergency.

Q: Is there a separate waiver to utilize the facility 24/7?

A: Yes! The waiver is required to be signed at the time of activation.

Apply Today for 24/7 Access

The Y Fits Your Busy Lifestyle

Members of the Scenic Rivers YMCA who are age 19+ are welcome to apply for 24/7 Facility Access. To apply for access, you must sign a 24/7 access waiver and agree to abide by our policies, submit a background check, and pay a \$25 activation fee*.

24/7 members are welcome to use the facility any time day or night, but no staff are available to assist members during non-staffed hours. Please see our website— <https://oilcityymca.org/> to view current staffed building hours.

Q: What's included when I sign up for 24/7 access?

A: By adding 24/7 access to your membership you will have access to the wellness center and gym areas late night and early morning hours, extended hours on the weekends, holidays, and potentially during inclement weather closures.

Q: What do I have to do to use the wellness facilities after normal business hours?

A: Those with qualifying membership types must activate their 24/7 access. This includes meeting with the membership director, signing a separate waiver, updating your profile picture in our system, submitting a background check, and receiving your key card.

Q: What does the key card access?

A: The special key card is separate from your regular membership key card and will open the entry door to our facility. Note: Members will not have access to the locker rooms outside of regular operating hours so members should make other arrangements if they need items after hours that are generally stored in lockers.

Q: Will my current membership key card work to access the facility during the hours the Y is typically closed?

A: No. When the facility is closed to non-24/7 members, you must use your access key card. Please proceed to the front desk and scan in with your YMCA card.

Q: What if a member is found to have violated the rules and guidelines stated in the 24/7 access waiver?

A: Adherence to the YMCA Code of Conduct and regulations is essential. Noncompliance may result in suspension or termination of YMCA membership. The YMCA reserves the right to revoke access and end the 24/7 membership at any time. Offenses include allowing non-24/7 access members to access the facility after hours, violating the YMCA Code of Conduct, disregarding safety, destruction of property, attempting to access spaces not included in the membership, and disorderly conduct while in the facility.

***If your access card is lost or deactivated due to membership lapse, you must sign the waiver and pay the activation fee again.**
